Based on the proceedings of the TSCHE cited, and on the recommendations of the University Inspection Committee, the University has accorded approval for grant provisional affiliation to **MNR Degree & PG College, Bhagyanagar colony, Kukatpally, Hyderabad** to start new course **M.Sc. (Analytical Chemistry)** with the intake of students and medium of instruction for the academic year **2021-2022**, subject to fulfillment of the conditions as stipulated by the Inspection Committee/TSCHE and general rules of affiliation.

CONDITIONS :


1. To appoint two teachers for M.Sc (Chemistry) and two teachers through duly constituted Selection Committee as per OU norms and obtain University approval.
2. To upload faculty information on the University web site.
3. To purchase books worth Rs.50,000/- for M.Sc (Chemistry) for the year 2021-2022.
4. To establish Laboratories with required equipment, material, chemicals and glassware required for the above courses as per norms.
5. To procure software required for the course.
6. To subscribe for five National and two International Journals for the year 2021-2022.
7. Teaching diaries and Students attendance registers are to be maintained as per norms.
8. Governing Body meetings are to be conducted thrice in a year by associating University representative on the Governing Body.
9. All the transactions includin payment of salaries to the staff should be made through bank.

You are, therefore, directed to submit the Compliance Report on the fulfillment of the above deficiencies in the following format along with the documentary evidence to reach this office **within one month from** the date of issue of these orders, through the University representative on the Governing Body of the College.
