CONDITIONS :


1. To appoint required teachers through duly constituted Selection Committee as per OU norms and obtain University approval for the academic year 2021-2022.
2. To purchase books worth Rs.15,000/- for the year 2021-2022.
3. Laboratory has to be strengthened by procuring required material, equipment, Chemicals & glassware as per OU norms.
4. To subscribe for three National and two international Journals for the year 2021-2022.
5. To upload faculty information on the University web site.
6. To provide parking facility.
7. To submit sanitary certificate for the year 2021-2022.
8. To submit Fire Safety Certificate from the competent authority.
9. Teaching diaries and Students attendance registers are to be maintained as per norms.
10. Governing Body meetings are to be conducted thrice in a year by associating University representative on the Governing Body
11. All the transactions including payment of salaries to the staff should be made through bank.
12. The faculty to be deputed for refresher courses/orientation programmes/Faculty Development programmes conducted by OU and other Institutions.

You are, therefore, directed to submit the Compliance Report on the fulfillment of the above deficiencies in the following format along with the documentary evidence to reach this office **within one month from** the date of issue of these orders, through the University representative on the Governing Body of the College.
