## **CONDITIONS**:

- 1. To appoint required teachers through duly constituted Selection Committee as per OU norms and obtain University approval for the academic year 2021-2022.
- 2. To purchase books worth Rs.15,000/- for the year 2021-2022.
- 3. Laboratory has to be strengthened by procuring required material, equipment, Chemicals & glassware as per OU norms.
- 4. To subscribe for three National and two international Journals for the year 2021-2022.
- 5. To upload faculty information on the University web site.
- 6. To provide parking facility.
- 7. To submit sanitary certificate for the year 2021-2022.
- 8. To submit Fire Safety Certificate from the competent authority.
- 9. Teaching diaries and Students attendance registers are to be maintained as per norms.
- 10. Governing Body meetings are to be conducted thrice in a year by associating University representative on the Governing Body
- 11. All the transactions including payment of salaries to the staff should be made through bank.
- 12. The faculty to be deputed for refresher courses/orientation programmes/Faculty Development programmes conducted by OU and other Institutions.
